RENTAL AGREEMENT

By signing this rental agreement, I, _____ (print name) understand and agree with the terms and conditions listed below:

- ❖ Before the dress chosen by the renter can be taken out of the shop, a **Security Deposit of \$50** must be paid by the renter. The security deposit is required to help cover damages incurred and repairs needed on the dress while it is in the renter's care.
- ❖ The security deposit is returned to the renter within a week of the dress's return to the store if it is in the same condition it was picked up in; not including dirtiness.
- ❖ A **Dry-Cleaning Fee of \$55** is required when a dress is rented. This is used by Mariah's Bridal to have the dress dry-cleaned after the renter has returned it.
- ❖ The renter is not allowed to dry clean the dress for any reason unless permission is given by Mariah's Bridal.
- ❖ If the gown is lost or damaged beyond repair, the renter will owe 75% of the dress's original buying price. Mariah's Bridal determines what constitutes as irreparable damage.
- ❖ The original buying price of this dress is _____.
- ❖ **Alterations** (if needed) must be paid for separately by the renter. Alterations can only be done if the owner of the gown allows them. By signing this contract, the renter agrees to pay for the permitted type of alterations done to the rented gown.
- ❖ The renter acknowledges that they are responsible for the pick-up, drop-off, and care of the dress/items rented between these dates:

- ❖ The renter agrees to return the dress at the agreed upon date. If returned after the determined drop-off date, the \$50 security deposit will not be refunded.
- ❖ If the security deposit is lost due to a late return the renter will have to pay for any repairable damages done.
- ❖ A **Holding Gown Charge of \$75** is applied if the renter wishes to rent the gown for a month or more. Renter cannot rent the gown for any longer than 6 weeks.

- ❖ **Split Rental Charge of \$25** will be applied if the renter wishes to split the rental period into two parts to accommodate for extra events farther than 2 weeks away from the wedding date.
- ❖ Mariah's Bridal is not responsible for cleaning the dress in between extra events or bridal shoots. Mariah's Bridal is only responsible for cleaning the dress after the final wedding day event once it is returned to the shop.
- ❖ **First come, first serve policy:** Between the time the renter chooses the dress and the time the renter picks up the dress from the shop for the rent, Mariah's Bridal reserves the right to allow other customers to try it on.
- ❖ No one will be allowed to use the same dress unless their wedding date falls after the first renter's wedding date. The date must also be under 3 months in advance for this policy to apply. The dress can still be reserved for any future date.
- ❖ Mariah's Bridal cannot put a dress on hold for longer than three months.
- ❖ **A Non-refundable Reservation Fee of 30% or 50% of the price of items being rented** is due upon signing.
- ❖ Mariah's Bridal reserves the right to raise the reservation fee to 50% if the gown is hot listed (very popular).
- ❖ No other rental fees are included in those percentages. These fees are required for the *first come, first serve policy* to be applied. No fee, no reservation.
- ❖ **The Reservation Fee** is non-refundable after the renter signs the agreement. Cancellations of the dress at any time will not allow a refund of the reservation fee.
- ❖ Under no circumstances can any money be refunded back to the renter from the grand total listed on the Rental Information Sheet after the gown has been worn by the renter.
